## CALL TO ORDER, FLAG SALUTE:

Mayor Olness called the regular meeting to order at 7:02 p.m. and lead us all in the Flag Salute.

## **ROLL CALL:**

## PRESENTATIONS, ANNOUNCEMENTS, APPOINTMENTS:

Stephanie Davisson and Patricia Davisson from Puget Sound Ghost Hunters provided Council with an investigation report prepared from their November 13, 2010 visit to the Black Diamond Cemetery and highlighted some experiences from the visit, but due to the weather they could not use much of their equipment and the photos taken mainly just showed the rain, they noted they would love to come back when the weather is more conducive.

#### **NEW BUSINESS:**

#### Resolution No. 11-734, updating the City's official fee schedule

Community Development Director Pilcher reported periodically City staff reviews the adopted fee schedule to ensure fee amounts are sufficient to cover the expense of providing various City services. He reported that changes to city codes and procedures at times, require the initiation of new fees to address new or modified processes. The proposed amendments are intended to address those situations. Mr. Pilcher thanked Amy

Donlan who put together the amendments to the fee schedule and noted the last significant amendments to the fee schedule occurred in August 2009. In addition, he added most of the changes occur in the lass use section.

A motion was made by Councilmember Saas and seconded by Councilmember Hanson to adopt Resolution No. 11-734, updating the City's official fee schedule. Motion passed with all voting in favor (4-0).

Information Services Manager Hanson addressed Council on the email problems the City was experiencing in January; he discussed the problem, the troubleshooting and the fix.
