SE 288TH STREET OVERLAY PROJECT CONSTRUCTION SUMMARY

Five bids were received with the lowest bid coming from Watson Asphalt Paving Co., Inc. for the amount of \$105,493.75. The project was awarded to Watson Asphalt Paving Co., Inc. via Resolution 11-756, dated June 16, 2011. A change order was authorized to increase the contract amount by \$4,863.25 and to increase the overall project budget by \$5,000 via Resolution 11-762, dated July 21, 2011. Substantial Completion for the project occurred September 16, 2011. Physical completion, which included striping, occurred September 30, 2011, with no remaining punchlist items.

The project was sent out to contractors for a second round of bidding and received one bid from Pivetta Brothers Construction, Inc. The project was awarded to Pivetta Brother Construction, Inc. via Resolution 11-763, dated July 21, 2011. Construction began September 6, 2011 and was complete September 16, 2011. Upon completion, there were no outstanding punchlist items.
