**ORDINANCE NO. 12-974** 

AN ORDINANCE OF THE CITY OF BLACK DIAMOND, WASHINGTON, RELATING TO CITY COUNCIL MEETINGS; AMENDING SECTION 2.04.010 OF THE BLACK DIAMOND MUNICIPAL CODE; ESTABLISHING A TOWN HALL REGULAR MEETING SCHEDULE; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, regular meetings of the City Council occur on the first and third Thursdays of each month; and

WHEREAS, the City Council desires to add a third regular meeting of the City Council for the purpose of holding informal Town Hall meetings to give members of the community an opportunity to discuss emerging issues and to voice concerns and preferences for their community as well as an opportunity for the City Council to solicit and provide information regarding specific topics affecting the community; and

WHEREAS, the City Council desires to amend the City Code to establish a regular schedule for Town Hall meetings;

NOW, THEREFORE, the City Council of the City of Black Diamond, Washington, do ordain as follows:

### Section 1. Amendment of BDMC 2.04.010 (Meetings).

The regular meetings of the City Council of the City shall be held at the Black Diamond Municipal Building, 25510 Lawson Street, Black Diamond, King County, Washington on the first and third Thursdays of each month at the hour of seven p.m., with the first such meeting to be May 7, 1998. Town Hall meetings of the City Council shall be held at \*\*, Black Diamond, King County, Washington on the second Thursday of each month at the hour of seven p.m. with the first such regular meeting to be held on March 8<sup>th</sup>, 2012.

Section 2. Severability. Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be pre-empted by State

or Federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

<u>Section 3. Effective Date</u>. This Ordinance shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of publication.

#### **RESOLUTION NO. 12-786**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, KING COUNTY, WASHINGTON AMENDING THE CITY COUNCIL RULES OF PROCEDURES TO ESTABLISH RULES AND PROCEDURES FOR TOWN HALL MEETINGS

WHEREAS, the City of Black Diamond has established rules and procedures governing the conduct of Council meetings, proceedings and business; and

WHEREAS, the City Council has established a regular meeting of the City Council for purpose of conducting regularly scheduled informal Town Hall meetings; and

**WHEREAS**, the City Council desires to amend the City Council Rules of Procedure to provide for town hall meetings;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, WASHINGTON, DOES RESOLVE AS FOLLOWS:

<u>Section 1.</u> The Rules of Procedure of the Black Diamond City Council are hereby amended as follows:

- A. <u>Amendment of Rule 2.4 (Schedule of Regular Meetings)</u>. Rule 2.4 of the City Council Rules of Procedure is hereby amended to read as follows:
- 2.4 <u>Schedule of Regular Meetings.</u> In accordance with Section 2.04.010 of the Municipal Code, the regular meetings of the City Council shall be held on the first and the third Thursdays of every month at 7:00 p.m. in the City Hall Council Chambers located at 25510 Lawson Street, Black Diamond, Washington. The regular meeting location may be changed by a majority vote of the City Council. <u>Town Hall meetings shall be held on the second Thursday of every month at 7:00 p.m. in the \*\* located at \*\*, Black Diamond, Washington; provided that,</u>

nothing herein prohibits the City from holding a Town Hall meeting during a special meeting of the City Council.

B. New Rule 3.21 (Town Hall Meetings) Added. Section 3 of the City Council Rules of Procedure is hereby amended by the addition of new rule 3.21 (Town Hall Meetings), reading as follows:

#### 3.21 Town Hall Meetings.

- 3.21.1 <u>Purpose</u>. Town Hall meetings are intended to be informal meetings of the City Council and members of the community of Black Diamond held for the purpose of providing interested members of the community an opportunity to discuss emerging issues and to voice concerns, opinions and preferences for their community as well as an opportunity for the City to provide information to the community and solicit information and opinions regarding specific topics affecting the community, and to respond to questions. It is not the purpose of Town Hall meetings to take final action on any matter before the City Council.
- 3.21.1 Town Hall Agenda. The agenda for a Town Hall meeting shall be prepared in conformance with Rule 3.1. The order of the Agenda shall be in conformance with Rules 3.2, 3.3, 3.4, 3.5, 3.17 and 3.19 of the City Council Rules of Procedure; provided that, the public comment period may be limited to specific topics identified in the Town Hall Meeting Agenda. The public comment period shall conform to Section 3.8.5 of the City Council Rules of Procedure. Rules 10.1 and 10.2 of the City Council Rules of Procedure will not be applicable to public comment period during Town Hall meetings. Presentations to be made during a Town Hall meeting shall be scheduled and presented in accordance with Section 3.8.4 of the City Council Rules of Procedure.

The presiding officer shall retain authority to impose rules of procedure to ensure open discussion during the Town Hall meeting, an equal opportunity for people with opposing or different viewpoints to speak, an opportunity for everyone who wants to speak to have a turn before anyone is allowed to speak a second time, and to ensure order and decorum. Where necessary, due to the number or persons who want to speak, the presiding officer shall retain authority to limit all persons' remarks to an equal period of time.

C. <u>Staffing</u>. City staff and the City Attorney shall not be required attend Town Hall meetings unless otherwise directed by the Mayor; with the exception that, the City Clerk, or designee, shall attend Town Hall meetings for the purpose of keeping a journal of the minutes of the meeting and to act as the City Council's parliamentarian in the absence of the City Attorney.

#### SUMMARY STATEMENT:

The police station/court/EOC is in need of a new generator to be used as a backup power supply when the power goes out. This also will fulfill a requirement of the latest International Building Code. The bid price is \$19,250 with estimated tax being \$1,828.75 for a total estimated cost of \$21,078.75.

See attached Staff Report for more information.

**Budget:** City originally anticipated using the generator donated to the City by the Fire Department, so funding was not included in the 2012 Capital Budget. Upon evaluation by the electrical contractor, the generator was found to be inadequate to meet the needs for the building

COMMITTEE REVIEW AND RECOMMENDATION: The Finance Committee met and reviewed this item at their February 9, 2012 meeting and recommended bringing forward to Council for adoption.

<u>Section 1.</u> The Mayor is hereby authorized to purchase a Kohler 25KW standby generator, model number 25REZG from EC Power Systems in Auburn for an amount not to exceed \$21,078.75.

#### POLICE DEPARTMENT GENERATOR BIDS:

We had an electrical inspection at the police, court, emergency operations building done by McGann Electric, who is a contractor on the MRSC small works roster. McGann determined what size generator was necessary to operate the building in a power outage. McGann determined that the generator we obtained from the Fire Department was insufficient to handle our needs at the police, court, emergency operations building.

I researched and e-mailed the State of Washington Procurement Office and determined that no generators were available on state bid.

I re-contacted McGann Electric who agreed to assist us in getting bids from three different companies who provide generators. Bids were received from:

CUMMINS POWER GENERATION: \$21,000.00 EC POWER SYSTEMS: \$19,250.00 CED INCORPORATED \$13,158.29

During the bid process we contacted our building official, Gregg Christenson to see if there were any special codes required for the generators. Greg came back with information which classified the building as a CLASS IV building due to the fact it is a public safety building and the emergency operations center.

After receiving the three bids, we met with McGann Electric and it was determined that the Cummins and EC Power's bids did meet the criteria for a class IV building and CED's bid did not. I called CED to see if they had a generator that would meet our code and they did not. In reviewing both the Cummins and EC Power Systems bids, McGann advised that either generator was sufficient for the needs of the building.

With all the information reviewed, I recommend we accept the EC Power Systems bid which was the lower of the two bids, meeting the necessary size and code requirements.
