BLACK DIAMOND CITY COUNCIL MINUTES July 18, 2013

CALL TO ORDER, FLAG SALUTE:

Mayor Olness called the regular meeting to order at 7:00 p.m. and lead us all in the Flag Salute.

ROLL CALL:

PRESENT: Councilmembers Deady, Goodwin, Edelman and Benson.

ABSENT: Councilmember Taylor (excused).

NEW BUSINESS:

Resolution No. 13-881, authorizing the Mayor and City Council to approve the "Xterra Black Diamond" Special Event

Permit Tech Supervisor Donlan noted that the Xterra event has applied for a special event permit. This is the sixth year for the triathlon with 500-600 participants/volunteers expected. She noted this is pretty much the same special event permit that they have submitted in the past however they did request to have an overnight camper on scene to protect equipment and they have also received approval to use the island to take swimmers across the lake. She commented that the application is complete.

Councilmember Benson asked if it was Xterra or Tough Mudders that asked about open fires.

Permit Tech Supervisor Donlan noted that open fires are prohibited and it was Tough Mudders that asked.

A **motion** was made by Councilmember Goodwin and **seconded** by Councilmember Benson to adopt Resolution No. 13-881, authorizing the Mayor and City Council to approve the "Xterra Black Diamond" Special Event. Motion **passed** (4-0).

Ordinance No. 13-1009, providing for a change of a way-of-travel name pursuant to an adjacent owner petition

Planning Director Welsh reported the City is responding to the Auburn/Black Diamond road notice that was provided. Staff has reviewed and concurs the change should be made, this change will provide consistency.

Councilmembers Deady and Edelman both agreed this was a great idea and will help the citizens as we build out to keep consistency.

A motion was made by Councilmember Edelman and **seconded** by Councilmember Deady to adopt Ordinance No. 13-1009, providing for a change of a way-of-travel name pursuant to an adjacent owner petition. Motion **passed** (4-0).

Resolution No. 13-882, authorizing the Mayor to execute a Local Agency Agreement with the Washington State Department of Transportation for a Federal Grant for replacement of street signs

Executive Director of Engineering Services/Ec. Dev. Williamson gave the background on this resolution and the GPS tool that was purchased. He noted that every road sign has been GPS'd and the City was able to borrow a retroreflectometer from WSDOT in December 2011/January 2012 and measured the retro reflectivity of all the City's signs. 292 signs do not meet minimum standards for reflectivity. Using information gathered it allowed them to get this Grant. He noted all the standards and requirements have been done.

A motion was made by Councilmember Deady and seconded by Councilmember Edelman to adopt Resolution No. 13-882, authorizing the Mayor to execute a Local Agency Agreement with the Washington State Department of Transportation for a Federal Grant for replacement of street signs. Motion passed (4-0).

DEPARTMENT REPORTS:

Fire Department – Chief Smith reported on a flyer he handed out to Council regarding Fire Engine 98 and explained the work that has been done.

Councilmember Goodwin noted this is on the top five of priorities in the CIP to replace Fire Engine 98.

Chief Smith noted this is one of the newer ones, but it does need to be replaced and would like the City to write a \$25,000 AFG Grant for a new one.

MAYOR'S REPORT:

Mayor Olness reported she attended a MISMAC and SCATBd meeting, she noted that a letter should be given to her soon regarding the transportation issue and will have it by the next meeting to share. She commented that Council received an email at Noon that the RCO grant has been granted and wanted to congratulate Mr. Nix, Mr. Boettcher and Mr. Williamson for all their hard work.

Councilmember Benson reported she attended the SCATBd meeting and noted that the area transportation issue is extremely important for the shipping in this area.

Councilmember Edelman noted she attended the SCATBd meeting for the first time and also noted how important the transportation issue is for our area.
