CALL TO ORDER, FLAG SALUTE:

Mayor Gordon called the regular meeting to order at 7:00:01 p.m. and lead us all in the Flag Salute.

ROLL CALL:

PRESENT: Councilmembers Deady, Edelman, Morgan and Benson.

NEW BUSINESS:

Ordinance No. 14-1034, extending the moratorium for the acceptance of applications for development within the MPD District, excluding any applications subject to the moratorium of the MPD developments entitled The Villages and Lawson Hills, previously approved under Ordinance No. 14-1025 on March 20, 2014

City Attorney Morris reported the reason we are here tonight is because the moratorium will be expiring soon and due to staffing we have not been able to complete the work that needs to be completed to lift the moratorium. She also noted written comments were received from Bill Kombol.

A **motion** was made by Councilmember Edelman and **seconded** by Councilmember Deady to include forestry exemption into this ordinance. Motion **passed** with all voting in favor (4-0).

Resolution No. 14-970, authorizing the Mayor to execute an agreement for jail services with Yakima County

Chief Kiblinger reported this agreement would be used for long term sentences from the Court. In an effort to keep costs down this agreement has the cheapest housing. She also noted that this agreement provides transportation.

A motion was made by Councilmember Deady and seconded by Councilmember Benson to adopt Resolution No. 14-970, authorizing the Mayor to execute an agreement for jail services with Yakima County. Motion passed with all voting in favor (4-0).
