Response to questions regarding interest in the position of councilmember for the City of Black Diamond.

1. Why are you interested in serving as a Black Diamond City Councilmember?

I would like the opportunity to be further involved in community decisions. My hope would be to have the chance to shape thoughtful meaningful decisions for the future of the City, as well as, laying the groundwork for present and future wise and prudent choices for the City.

2. What strength would you bring to the Council?

I am a person driven by the big picture and then enjoy working down to the details. I believe I bring a strong sense of community by wanting to work for the common good even if it is not necessarily to my advantage. I am educated, and have a trained mind. One of the ways this is demonstrated is by careful listening, and another way is by having practical experience problem solving and wrestling with thorny issues. I bring excellent people skills and am used to working cooperatively and collegially toward a common goal with a group of people. I have worked successfully within bureaucracies, and have come to some understanding of their constraints and how to accomplish goals within them. I have demonstrated leadership ability having been advisor, chair, commissioner, coordinator, head coach, president, pitcher, and supervisor; in organizations I have been part of in the past.

2. What are the three highest priorities and/or issues you believe the City needs to address? How would you propose to address these issues?

At this time I think the three highest priorities for the City come under the heading of Growth: which are: density, transportation, and water. Before I make any comment, the disclaimer is I am not an expert. As a citizen and a voting resident of Black Diamond for the last twenty years or so, there has been the opportunity to observe and even engage in some of the issues facing Black Diamond.

Growth: King County has slated Black Diamond for a certain amount of growth by 2025. It seems a reasonable target 1099 new residences. On the other hand, the City has entered into agreements to augment this number to 6,000 new residences by 2025. Therefore, there are many adjustments to consider for a small rural City of 4,300 residents.

First, density: We all, myself included, need to understand what this looks like and how it works. Density is how crowded a land space can be according to the specified rules and regulations. To me the wildcard here is the Transfer of Development Rights (TDR). I don't know the solution to this: however; as the public I would like to be educated in how to apply this term and to see some visualized simulations of what exactly this could mean to homeowners, landowners, and business owners in the community. The other piece here is where has this practice been carried out previously and how is it working?

Second, transportation: Unfortunately, I have no solution to this and apparently neither does King County countywide. For the City, I know there are people with far more expertise than mine working on this making sure all transportation issues related to the developing increase in traffic are properly researched and addressed. As to what the City can do, it would be good to know exactly what rights the City has. What are the mechanisms that drive decision making so the City can leverage their part in transportation plans that favor the City and partner with agencies early to have the best chance to make modifications and changes. A question might be, does the City want a transfer station like Renton and Federal Way?

Third, water: My understanding is that Black Diamond is three-quarters water. We have groundwater, storm water, lakes, ponds, streams, creeks, pristine bogs, surface water, drainage basins, underground aquifers, wetlands, sensitive areas, fish and wild life habitat, and mines filled with water some of it hot water. In light of just how unique the City is in this regard, I think the City needs to hire a licensed independent wetlands scientist to make sure any developing does not have an adverse affect on all the water configurations.

Overall, I think we all need to go out of our way to be sure the City, we the voters, and our unique community are being well served in terms of beginning to develop a balanced community that can support thoughtful smart growth and retain our unique natural setting.

 Explain your current and past community involvement and/or service on city, nonprofit, or public boards, committees, task forces, or commissions and how this has contributed to the Black Diamond community. Address its relevance to the position of Black Diamond City Councilmember.

I have some experience that can be applied to the position of council member. For example, I served on the board of a not-for-profit organization for twelve years. During that time, I served in each elected position including the last three years of service as the President of the eight person Board of Directors for Evergreen City Ballet located in Auburn and then in Renton. Also, for six years of that same time frame, I served as Chair of the twelve person Renton Municipal Arts Commission. This was also a volunteer position.

These experiences have given me the opportunity to meet challenges and deadlines, fulfill fiduciary responsibilities, fill out applications, attend meetings, create future plans and goals, work with like minded people, see plans and hopes and dreams come to fruition. For the ballet it was the dancers, the performances, developing funding sources, and a balanced budget. For the Arts Commission it was the process of interviewing artists for new a public art works, cataloging existing public art, commissioning community based arts direction, and encouraging community art engagement with small community grants, partnering with other groups, developing funding sources, and staying within budget.

5. What do you wish to accomplish during this appointed term as a Black Diamond City Councilmember?

Whatever is accomplished it will be the City Council that accomplishes it together. I hope to work with my colleagues to be able to impact the growth of the City in productive and positive ways. I would want to see incremental balanced growth that City infrastructure and its natural physical limitations can successfully support.

I would like to be part of the council reaching out to other small cities and discussing our issues.

I would also want to make sure that every opportunity for public input, ideas, and opinions are advertised and encouraged.

6. What is your vision for our City and community?

I believe that I focus on the vision for the future of Black Diamond and what that could be. Showcasing the value of Black Diamond especially in three areas: the culture; the unique land and water configurations; and the history of the city build accessible community activities, civic awareness, and pride in Black Diamond.

We need to continue to support showcasing the value of the culture of Black Diamond. Can the city entice small high tech businesses and/or encourage entrepreneurship? Can Green River Community College have a presence in the City? Have we identified other arts or cultural assets within the City? http://www.4culture.org/apply/artprojects

Our land and water configurations are unique. I would like to see the City have better control over what happens within its limits without overwhelming the physical land and water configurations. Are we exploring what an active salmon stream means to the City? Have we considered a golf course for some of the open space? How about miniature golf?



Can we begin to see the City as developing new destinations by adding to the Bakery and the Labor Day Festivities that already exist?


7. Is there anything else you would like to add that would help us get to know you a little better?
