CALL TO ORDER, FLAG SALUTE:

WORK SESSION:

Mayor Benson welcomed everyone and introduced Finance Director Miller to discuss property tax.

1) Discussion on Property Tax

Finance Director Miller reported that Washington State has more RCW's and rules than most states. She reported on requirements and timelines and rules pertaining to percent of increase for taxes. She discussed the requirements for cities under 10,000 and rules that govern how those are figured out with the inflation factor.

She reported on the budget for Black Diamond for year 2017 and shared a graph that showed historical information from 2011 to 2017 estimate.

Points and topics of discussion:

- Washington uses the one percent measurement.
- ❖ Public Safety revenue estimate of taxes that will be collected for year 2017.
- Expenditures for the Police budget.
- How Public Safety is funded from the property tax dollars received in addition to other fees and taxes the City receives.

- ❖ In addition to the one percent, new homes that are completed, the city will get an estimate of construction value.
- Governments and schools are exempt from paying property tax.
- ❖ Most increases in property tax bills are due to school and fire districts.
- ❖ Black Diamond's levy rate.
- Potential levy for Black Diamond. How the levy will be adjusted down by King County to the actual amounts, but cannot be increased.

Mayor Benson shared that next year, this will be going to legislature to change the property tax with a ceiling of five percent to raise property tax for citizens in the city. If cost of living goes up five percent, we can raise the property tax rate by five percent. She further reported that you cannot collect more than you need for public safety.
