

**ORDINANCE NO. 18-1103**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, KING COUNTY, WASHINGTON, AMENDING SECTION 2.04.010 OF THE BLACK DIAMOND MUNICIPAL CODE FOR CONSISTENCY WITH COUNCIL RULES OF PROCEDURE; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, the Black Diamond City Council has recently approved revisions to the City Council Rules of Procedure via Resolution No. 18-1242; and

**WHEREAS**, Black Diamond Municipal Code (“BDMC”) Section 2.04.010 needs to be revised for consistency with Council Rule 2.4 regarding the location and scheduling of regular meetings;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1. BDMC Section 2.04.010 Amended.** Section 2.04.010 of the Black Diamond Municipal Code is hereby amended as follows:

**2.04.010 Meetings.** The regular meetings of the city council of the city shall be held at the City Council Chambers located at 25510 Lawson Street, Black Diamond, King County, Washington, on the first and third Thursdays of each month at the hour of seven p.m. A work session of the city council shall be held at the City Council Chambers located at 25510 Lawson Street, Black Diamond, King County, Washington, on the second Thursday of each month at the hour of six p.m. Town Hall meetings shall be held at the City Council Chambers located at 25510 Lawson Street, Black Diamond, King County, Washington on the second Thursday in the months of March and October at the hour of seven p.m. Regular meetings, work sessions, and Town Hall meetings may be canceled or rescheduled by a majority vote of the city council in an open public meeting. The Mayor or a majority of the City Council may cancel a regular meeting, work session, or Town Hall in case of emergency or other unforeseen events by notifying the City Clerk.

**Section 2. Severability.** Should any section, paragraph, sentence, clause, or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

**Section 3. Effective Date.** This Ordinance shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of publication.
