**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
BLACK DIAMOND, KING COUNTY, WASHINGTON  
ACCEPTING A PROPOSAL FROM WILBERT PRECAST,  
INC. TO FABRICATE AND INSTALL TWO 24-UNIT  
COLUMBARIUM WALLS AT THE CEMETERY**

**WHEREAS**, the Black Diamond Cemetery Board has expressed a desire for new niches at the cemetery; and

**WHEREAS**, there is a demand for niches at the cemetery; and

**WHEREAS**, the City has planned and budgeted for the installation of new niches at the cemetery; and

**WHEREAS**, Wilbert Precast, Inc. provided the existing niches at the cemetery; and

**WHEREAS**, City staff reached out to Wilbert Precast to provide a proposal and will be purchasing pursuant to BDMC 2.90.010(C) and RCW 35.23.352(1);

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BLACK DIAMOND, WASHINGTON, DOES RESOLVE AS FOLLOWS:**

**Section 1.** The City Council hereby accepts the proposal from Wilbert Precast, Inc., to fabricate and install two 24-unit columbarium walls at the cemetery and, authorizes the Mayor or her designee to execute a purchase order substantially in the form attached hereto.

RE: Columbarium Walls @ City Cemetery

Dear Dan:

The following is a updated proposal to furnish and install in your prepared excavation, two 24-unit single sided columbarium walls. The price is \$ 19,958.00. If this proposal meets with your approval please sign and email back to me. Upon receipt of signed proposal, we will invoice (\$ 9,980.00) for niche fronts, niche castings and brass hardware with payment due in 30 days. Balance will be due upon delivery of wall.

**OUR PROPOSAL INCLUDES THE FOLLOWING:**

1. Precast concrete niche spaces shall be approximately 10 1/2" wide x 10 1/2" high x 11" deep inside.
2. Columbarium is fabricated on concrete base & shall be supplied with precast concrete foundation (approx 12" thick) installed by Wilbert.
3. Precast concrete sidewalk (36" wide) shall be installed at front of wall.
3. Masonry shall be either Elk Mountain LedgeStone or Rocky Mountain Mossy natural stone with dark gray mortar. Sill @ bottom of fronts shall be 3" solid "Vintage Mission" brick.
4. Niche fronts shall be 12" x 12" Rushmore Mahogany polished granite. 2 extra will be provided.  
(Note: Existing wall has Swedish Royal Mahogany granite)
5. Top cap shall be Mahogany Sunset granite polished top & rock face edges.  
(Note: Existing wall has concrete cap)
6. Niches to be furnished with inner seals and one spanner head screwdriver for removing vandal resistant screws at brass rosettes.

**MISC NOTES:**

- \* Columbarium is similar to existing units. The granite and stone are slightly different due to existing materials no longer available. We have also quoted a granite cap in lieu of concrete on this proposal due to its durability.
- \* Cemetery shall provide minimum 10'-0" wide access to within 20'-0" of site & supply cemetery worker to help.
- \* Drawings indicating the size of foundation and excavation shall be provided by Wilbert Precast prior to install.
- \* Engraving of granite fronts is not included in this bid.
- \* Sales tax is included (8.6%)
- \* Excavation, gravel base, backfill, landscaping, irrigation work, walkways, etc are not included.
- \* Please allow approx 90 days from date of signed proposal to completion / installation.
- \* Proposal valid for 30 days.
- \* Samples of materials was sent in April 17th proposal.
