

REQUEST FOR BIDS FOR 2021 CITYWIDE ASPHALT OVERLAY PROJECT CITY OF BLACK DIAMOND

The City of Black Diamond is requesting asphalt grinding, patching and overlay work for multiple locations within the City in two schedules of work. Schedule 'A' consists of roadway pulverization and a 2-inch asphalt overlay of James St. between SR 169/3rd Ave. and 4th Ave., 4th Ave. between James St. and Park St., Park St. between SR 169/3rd Ave. and 4th Ave., Baker St. between 5th Ave. and 6th Ave., Hammond Pl. between Baker St. and end of road, and 6th Ave. between Baker St. and Lawson St. Schedule 'A' will also replace three sidewalk curb ramps on 6th Ave. Schedule 'B' consists of a 2-inch asphalt overlay on Railroad Ave. between Morgan St. and the end of road, a 2-inch asphalt overlay on the north section of 5th Ave. where the road turns east from the edge of existing pavement to the end of the road, and a 4-inch overlay on the southern portion of 5th Ave. from Pacific St. to the end of road. All roadways to be paved in Schedule 'B' are currently gravel and will be prepped by the City prior to the overlay. The City is requesting unit price bids for each category of work as defined in both schedules of the attached bid proposal form/Scope of Work.

The City will mark overlay limits in the field prior to bid closing. The City will freshen the overlay limits paint after award of the project (see Plans).

Small Works Roster bids must be turned in electronically in pdf format to Scott Hanis, Capital Project/Program Manager, **by 11:00 am on Tuesday, April 27, 2021**. If you are unable to submit your bid in electronic format, please contact Scott for other arrangements. The pdf copy of your bid must still be signed. E-mailed bids shall be sent to and received by Scott Hanis: shanis@blackdiamondwa.gov by the time stated above. The City will not accept late e-mail submittals or those delayed due to file sizes or incorrect e-mail addresses. An acknowledgment that the bid was received will be sent. All contract documents, plans, specifications, and addenda will be published on the City's Small Works page on the City's website: http://ci.blackdiamond.wa.us/Depts/PubWorks/works_roster.html.

Invitations to bid will be sent to all contractors registered on the City's Small Works Roster located at <http://www.mrscrosters.org> under the category of "Roadway Construction, Repair, and Maintenance" and sub-categories of "Asphalt Pavement Roadways" and "Roadway Construction" at the time of advertisement. Bids will also be accepted from contractors registered on the Small Works Roster at the time of bid closing.

Bid guarantees, such as bid bonds, will not be required for this bid. There will not be a public opening of bids.

2. The bid shall be awarded by the sum of the total of the bids for the 7 categories of work in Schedule ‘A’ and the 4 categories of work in Schedule ‘B’.

The undersigned has checked the amounts below and understands that the City will not be responsible for any errors or omissions on the part of the undersigned in making up this bid.

In order for the Owner to consider a bid, all items on the bid must be filled in completely.

3. It is agreed that this bid may not be withdrawn within a period of sixty (60) days after the date set for the opening thereof.
4. In accordance with this bid and the City Contract, the undersigned further agrees to so plan the work and to prosecute it with such diligence that said work shall be commenced within ten (10) days after issuance of a notice to proceed.
