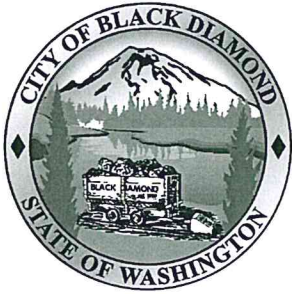

Meeting called to order by Mr. Boettcher at 3:30

Attendees: Howard Botts, Gomer Evans, Vicki Harp, Dee Israel and Don Mason (board members); Also present, Mayor Carol Benson, and PW Director ,Seth Boettcher

- 1. Review Meeting Notes from August 18, 2015** The meeting notes from August 18th, 2015 were reviewed. No edits were recommended. Vicki Harp moved to approve the notes as presented. The motion was seconded by Dee Israel. The motion passed with all voting in favor (5 – 0)

GENERAL COMMENTS: May 7 there will be celebration of the 40 year anniversary of the Black Diamond museum. A famous singer who specializes in John Denver songs will be there. Early cemetery records were lost when the cemetery curator, Jack Jones died in the early 50's and the family when cleaning out his house did not save the records or never did get them to the City.

- 2. Cemetery Bylaws Overall Review & Recommendation** Staff and the board reviewed the bylaws section by section making some formatting changes, double word deletions, punctuation, clarification on Saturday burials, change to allow trimming and pruning by citizens and removing time frames from cut flowers or artificial flower removal and reducing the vehicle speed in the cemetery to 5 mph. With those changes, the Howard Botts made a motion: Whereas the City has not had comprehensive official bylaws to govern the maintenance and operation of the Black Diamond Cemetery and whereas the board has reviewed various issues regarding the operation and maintenance of the cemetery and developed appropriate codes to guide City staff in the operation and maintenance of the cemetery; he then moved to approve the cemetery bylaws prepared by the cemetery board and as edited on February 16th, 2016 and refer them to the City council for consideration and adoption

3. **Spring Cleanup Dates** The spring cemetery clean up date was set for May 14th, 2016, the second Saturday in May. More volunteers are needed. The City will put a call for volunteers in the City's quarterly newsletter. Don Mason will write an article for the paper regarding the clean up day. Don would like the use of pressure washer, and top soil for leveling.
 4. **Cemetery Board Terms** Dee Israel said that she would probably be willing to serve another term, but would like the Mayor to check back in with her later in the year.
 5. **Adjourn Meeting** A motion to adjourn at approximately 4:30 was made by board member Evans , seconded by board member Botts. The motion passed (5 – 0)

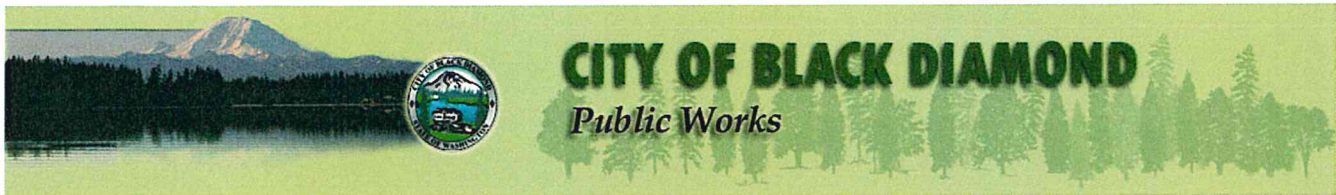

CEMETERY

Black Diamond's Historic Cemetery is located at 24431 Morgan Street.



The city-owned Black Diamond Cemetery, founded in 1884, sits on Cemetery Hill Road, hidden by a row of trees and marked by a wooden sign erected by local Scouts.

The cemetery has more than 1,200 graves, giving visitors a sense of the cultural diversity and tragedy that existed in Black Diamond when coal mining was at its peak. Tombstones mark graves of residents who came from Wales, Italy, Australia, Russia, Germany and many other countries.

Mayor Howard Botts says a Civil War veteran is buried there, as are many children who died in the early 1900s in epidemics of small pox and the flu. At least half a dozen graves mark those of mine workers who died in explosions in 1902, 1910 and 1915.

The cemetery was added to the National Register of Historic Places in April 2000.

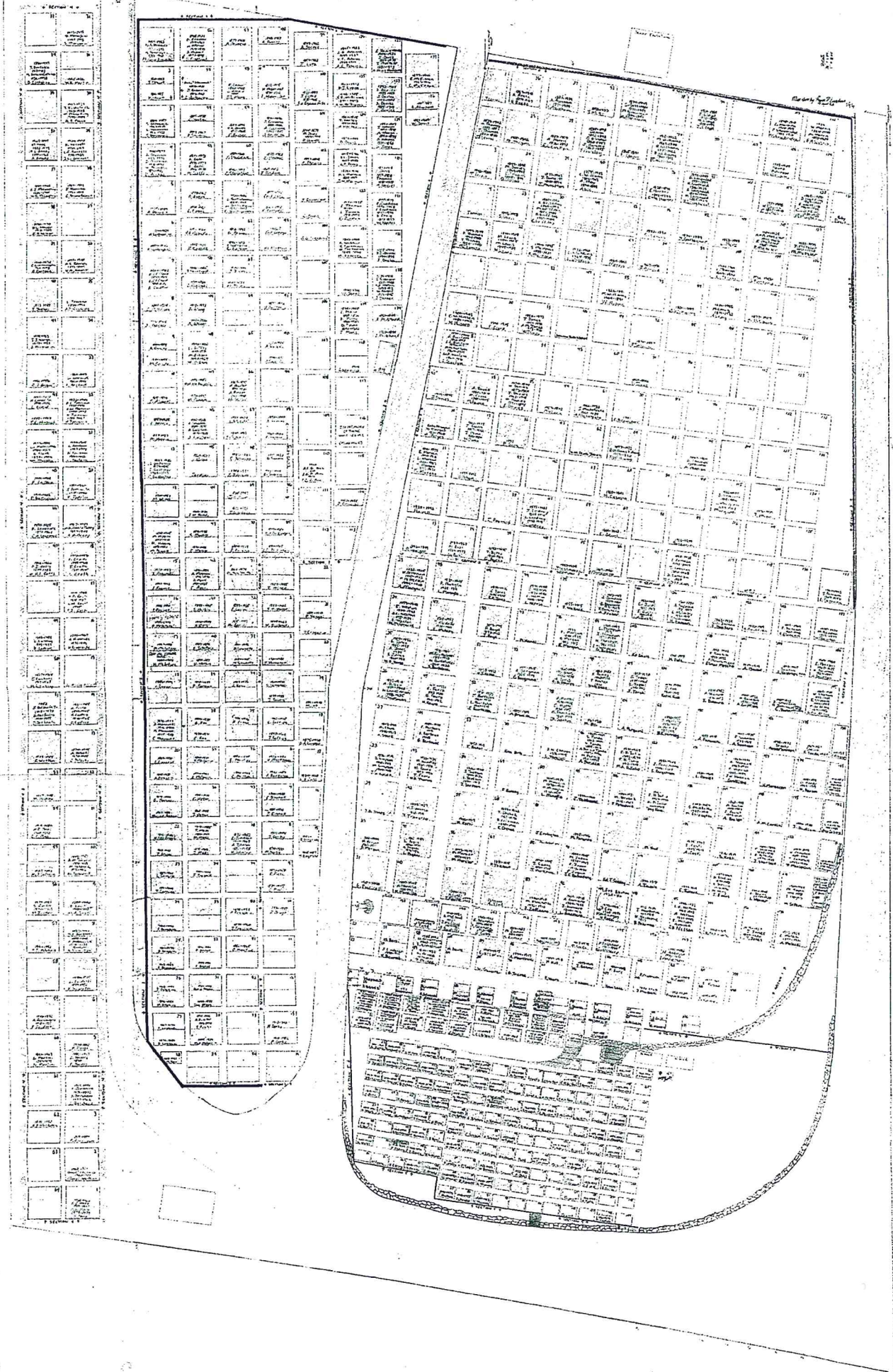

ORDINANCE NO. 13-999

AN ORDINANCE OF THE CITY OF BLACK DIAMOND, WASHINGTON, RELATING TO ESTABLISHMENT AND ADMINISTRATION OF PUBLIC CEMETERIES; REPEALING AND RE-ENACTING CHAPTER 12.12 BDMC TO RE-ESTABLISH A CEMETERY BOARD AND TO CONFORM THIS CHAPTER TO APPLICABLE STATE LAW; PROVIDING FOR VESTED RIGHTS AND RIGHT OF DESCENT AND SURVIVORSHIP; PROVIDING FOR TRANSFER OF OWNERSHIP; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, RCW 35A.68.010 provides that the City may exercise the powers to acquire, own, improve, manage, operate and regulate real and personal property for the operation of a city cemetery or other place for the burial of the dead, to create cemetery boards or commissions, to establish and manage funds for cemetery improvement and care and to make all necessary or desirable rules and regulations concerning the control and management of burial places and the investment of funds relating thereto and accounting therefor, all as authorized by Chapter 68.52 RCW; and

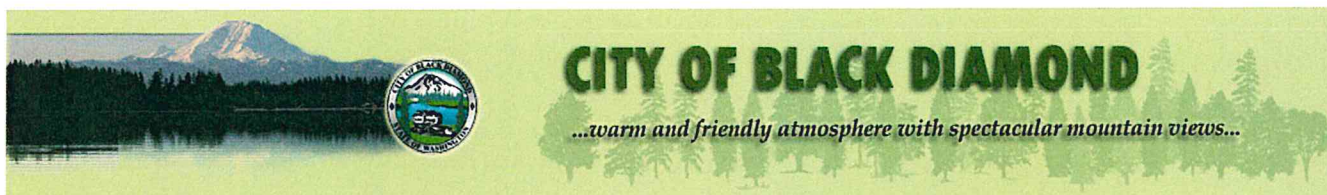
WHEREAS, the City Council in 1978 enacted Ordinance No. 210, codified at BDMC Chapter 12.12, establishing the Black Diamond Cemetery as a non-endowment cemetery pursuant to the provisions of Chapter 68.40 RCW, and providing for the creation of a cemetery board, and establishing the duties and obligations of the cemetery board, and providing for the administration of the Black Diamond Cemetery; and

WHEREAS, former RCW Chapter 68.40 RCW is no longer applicable to the administration of the Black Diamond Cemetery and it necessary to re-establish the Black Diamond Cemetery pursuant to Chapter 68.52 RCW, and

WHEREAS, the City desires to amend the City Cemetery Code to conform to the current requirements of Chapter 68.52 RCW and other applicable state laws; and

WHEREAS, the City Council desires to dissolve the non-functioning cemetery board and create a cemetery advisory board solely as an advisory body to the Mayor and City Council; and

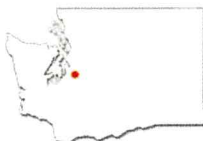
WHEREAS, the City Council finds that it is in the best interest of the public health, safety and welfare to amend the Cemetery Code as set forth herein;

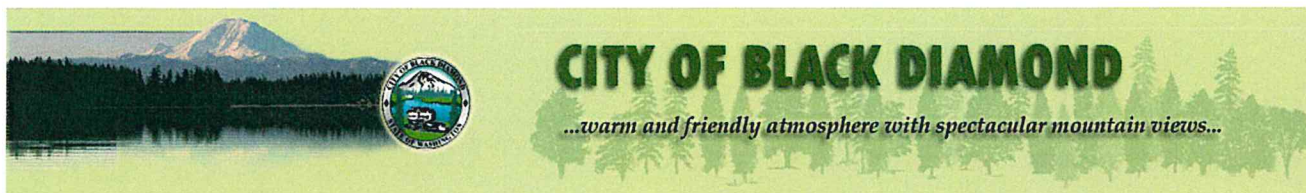
