**Description of Proposed Project:** A four-lot short plat which consists of the division of one existing lot of approximately 1.61-acres (70,131 sq. ft.), for the purpose of constructing four single-family homes on which the existing lot (lot 1 of 4) contains a single-family residence with a detached ADU under construction.

**Preliminary State Environmental Policy Act (SEPA) Determination**: The proposed project is categorically exempt from a SEPA threshold determination and EIS requirements.

Other Applicable Codes Which May Require Additional Project Review/Permits: Additional permitting and/or review will be required under BDMC Title 15, 17, 18, and 19.

A preliminary plat is a Type II, Administrative Decision. Any interested party may appeal a Type II Director's Decision to the City of Black Diamond Hearing Examiner within 14 calendar days of the Notice of Decision. A Notice of Decision will be provided to all parties of record.
