The HAP makes policy recommendations that could potentially result in housing development that could have short term impacts. If that is to occur, development would be subject to Black Diamond's municipal code, and impacts would be addressed and mitigated at the time of review. However, at this time they are recommendations only.

Proposed measures to protect or conserve plants, animals, fish, or marine life are:

It is not anticipated that the HAP will have any affect to plants, animals, fish or marine life. All housing development that could result from policies implemented in the future will be required to comply with the Black Diamond Municipal Code.

3. How would the proposal be likely to deplete energy or natural resources?

Proposed measures to protect or conserve energy and natural resources are:

The HAP will not deplete energy or natural resources. However, housing development that would require energy and natural resources could result from policies implemented in the future. They will be required to comply with the Black Diamond Municipal Code and mitigation will be assessed at the time of review.

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

Proposed measures to protect such resources or to avoid or reduce impacts are:

The HAP will not affect environmentally sensitive areas or areas designated for governmental protection. It recognizes those areas as important to preserve and any development that occurs as a result would be subject critical area regulations in place at the time of the proposal.

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

Proposed measures to avoid or reduce shoreline and land use impacts are:

The HAP will not affect land or shoreline uses, as no policies are directly implemented as a result of adopting the HAP. Any future development that could occur as a result would be subject to the land use code and shoreline code in place at the time of the proposal.

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

Proposed measures to reduce or respond to such demand(s) are:

If policies recommended within the HAP are adopted, Housing development could occur as a result. Proposals will be measured against allocated growth targets and current capacities for roads and utilities. Additional housing would likely increase demands on transportation or public services and utilities. However, impacts will be evaluated at the time of proposal and proper mitigation such as impact fees will be applied.
